Evidence Based Medicine (EBM) and Evidence Based Policy-Making


Sackett definition on EBM: "

the conscientious, explicit,
and judicious use of current
best evidence in making
decisions about the case of
individual patient'.

Cookson provides the same definition, but applied to society, not individual patient decision making (Evidence Based Policy-Making)

Model of Evidence Based Policy Making

The aim of the research on social determinants of health

To support health policy change by:

- assembling and
- promoting effective evidence-based models and practices

that address social determinants of health.

Notes

The research must

- 1. lead the way in demonstrating the relevance, feasibility and value of addressing social determinants.
- 2. The next step is the translation of the knowledge into concrete, workable actions through identifying entry-points, establishing cooperation with the key stakeholders and
- 3. identifying possible sources of resistance or opposition as well as possible sources of support.

- Academic in universities
- Researchers in research units
- Researchers in management consultant firms

- The capacity in technical matters is good, but:
- Their capacity of making policy making influence is poor.

• Why?

The case of Universitas Gadjah Mada

- There are more than 10 working groups on Social Determinant for Health
- The members are technical person
- The research needs to be put in the policy making agenda

- Group A (Alcohol, Tobacco, Violence and Injuries)
- Group B(Cardiovascular, Diabetes, Cancer)
- Group C(Food Safety, Child Health and Nutrition, Maternal Health, Oral Health)
- Group D(Malaria, HIV/AIDS, Tuberculosis, Neglected Tropical Disease)


The fact

- Limited policy influence agenda
- Policy influence done in some working groups through senior members who become advisors to Ministry of Health or local government
- Not all member understands about policy making process: policy agenda, formulation, policy implementation, and policy monitoring/evaluation.
